Tax Year - The form is for tax year 2024

Tax Credit Limits

Single/head of household – lesser of tax liability or \$2,500

Married filing jointly – lesser of tax liability or \$5,000. Names and SSN's are required for both taxpayers.

Married filing separately – lesser of tax liability or \$2,500

Owners of interests in pass-through entities

(S corporations, LLCs and partnerships) - Up to \$25,000 per owner.

Indicate your tax filing status as individual (married/single/head of household).

C corporation and fiduciaries (estates and taxable trusts) - up to 75% of state estimated income tax liability

Signing the form

The form must be signed by hand. If you wish for electronic signature capability, you are invited to use the online form at www.gracesholars.org.

Submitting the form

After completing, printing and signing the form, you have three ways to submit the form to GRACE.

How GRACE uses the information

GRACE uses your information to apply for your tax credit. The staff enters the information into the Georgia Department of Revenue's (DOR) self-service portal at the Georgia Tax Center website. When GRACE receives notice that you have been approved, it uses the information to complete and acknowledge your contribution.

What happens next?

GRACE will acknowledge the receipt of this form by email or mail. In January 2024, GRACE will enter your information into the Department of Revenue's online portal to apply for your tax credit.

When will I know if I am approved for a tax credit?

The DOR will have 30 days from the date of submission to act on your tax credit application. You should receive an approval letter in January 2024.

Payment Information

Payment may be made after the approval date given in your approval letter from the DOR. You must make your payment within 60 days of approval. Please initiate payment no later than a week before the end of the 60-day period. GRACE will process your payment only when the DOR notifies GRACE of your approval. Your payment options are:

- Stock or mutual fund shares





Entering Designations

Please use the information to complete the Designations section of the pre-registration form.

You may choose *up to three designations* by listing the amount for each entity (school or general fund) up to the total amount of the donation. To be sure the gift is properly credited, please include names of designations, cities for schools and the three-digit designation codes. Non-GRACE schools can be entered manually and do not require a three-digit code.

If scholarship needs are filled at a designated school, funds may be directed to another school with unmet need to comply with state law regarding the minimum annual distribution of funds.

GENERAL FUNDS

The GRACE board allocates the general funds (Board Choice or the Economically Disadvantaged Family Fund [EDFF]) to schools with the greatest need. Board Choice is the default selection if no designation is selected. Board Choice helps students with a broad range of financial need. EDFF helps students with the greatest financial need (i.e., they qualify for free or reduced lunch).

State and federal laws do not permit the designation of scholarships to specific individuals or families.
